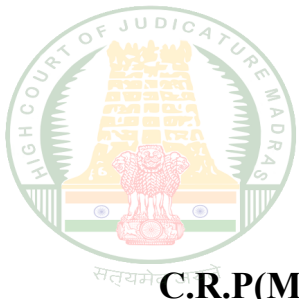

ORDER

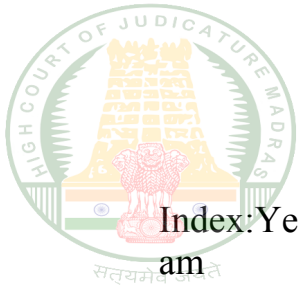
The learned counsel appearing for the petitioners seeks permission of this Court to withdraw all the Civil Revision Petitions and he has also made an endorsement to that effect.
