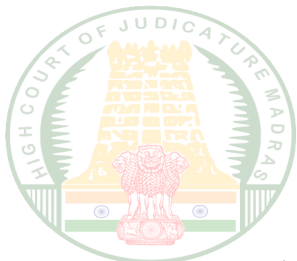

3. The learned Government Advocate (Criminal Side) submitted that the petitioner has been complying with the condition regularly.

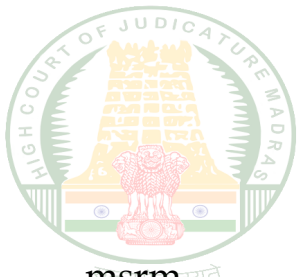
