ORDER

2. Heard the learned counsel for the parties. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

When the matter was taken up for hearing, the learned counsel for the petitioner submitted that, although several grounds have been raised in the writ petition, it would suffice if this Court issues a direction to the first respondent to consider the petitioner's representation dated 07.04.2025 and pass appropriate orders thereon, within a time frame to be fixed by this Court.
