2.The 3rd respondent has sent a communication, dated 10.06.2025 to the Revenue Divisional Officer stating that the place of death differs. Therefore, they cannot issue the certificate.

3.The petitioner ought to challenge the said communication. Therefore, the present writ petition cannot be entertained. Hence, the writ petition is dismissed. However, the petitioner is at liberty to challenge the
