This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P.(MD).No.3757 of 2025 dated 27.02.2025.

The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P.(MD).No.3757 of 2025 dated 27.02.2025 and this Hon'ble Court enlarged the petitioner on anticipatory bail. Due to his ill health, the petitioner could not able to mobilize fund to arrange sureties, so that, he is unable to produce the sureties before concerned Magistrate Court within the time stipulated by this Court. For the said reason only, he is unable to comply the conditions imposed by this Court in Crl.O.P.(MD).No.3757 of 2025 dated 27.02.2025.
