ORDER: The Court made the following order :-

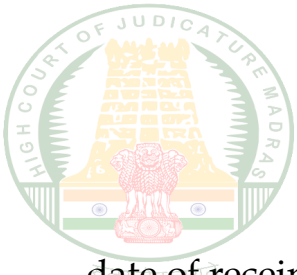

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P.(MD).No.6892 of 2025 dated 25.04.2025 and this Hon'ble Court enlarged the petitioner on anticipatory bail. Due to his ill health, the petitioner could not able to mobilize fund to arrange sureties, so that, he is unable to produce the sureties before concerned Magistrate Court within the time stipulated by this Court. 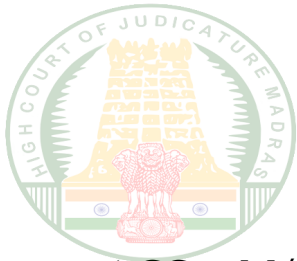
