Prayer in WMP(MD)No.14656 of 2025

This Petition filed under Article 226 of Constitution of India to direct the respondent herein to accept the amount Rs.5,35,870/- deposited on 13.03.2024 vide Ref.No. DI3303240033009 towards and adjust the same towards the conditional payment to be deposited by. the petitioner as per the order passed by this court in W.P.(MD).No. 16070 of 2025 dated 16.06.2025 and also to consider the reply to the show cause notice given by the Petitioner on 30.06.2025.

consequently direct the respondent to re-open the proceedings pursuant to the impugned order passed by the respondent dated 09.10.2024 by providing another opportunity to the petitioner to produce all the documents.

"This miscellaneous petition has been filed to accept the amount of Rs.5,35,870/- paid by the petitioner on 13.03.2024 towards the partial pre-deposit as ordered by this Court.

2. It is submitted that post facto the petitioner also deposit the balance amount of Rs.5,258/- and thus in total, the petitioner has deposited a sum of Rs.5,41,128/- being 25% of the disputed tax amount of Rs.21,64,514/-.

3. Considering the same, this petition is allowed."

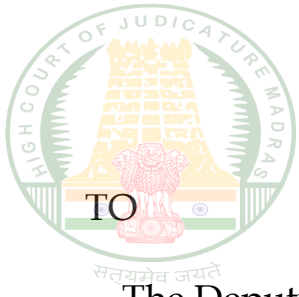
