The committee constituted by the Government to initiate action against the unauthorized construction is admittedly functioning. Therefore, in the event of any complaint, the committee has to initiate appropriate actions.

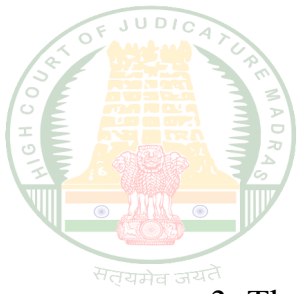
