In the event of identifying any encroachment in that locality, all appropriate actions will be initiated to remove the same.

3.In view of the said submission, the respondents 3 and 5 are directed to conduct a survey and identify the encroachments, if any and thereafter, initiate all appropriate actions to remove the encroachments by following the procedures as contemplated under the statutes and rules in force. The said exercise is directed to be completed within a period of twelve weeks, from the date of receipt of a copy of this order.

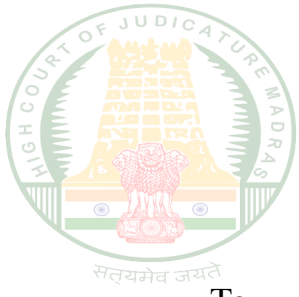
4.With the above direction, the writ petition stands disposed of.
