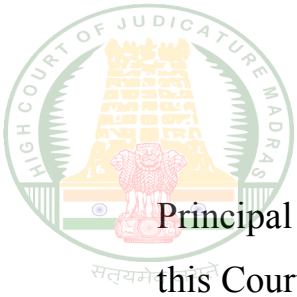

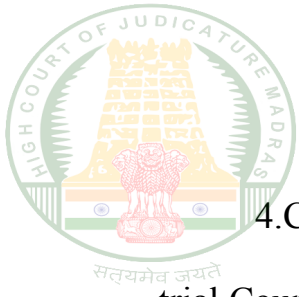

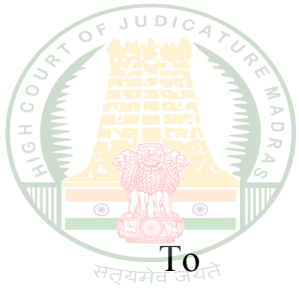
4.Considering the limited request of the petitioner, this Court directs the trial Court to dispose of the suit in 113 of 2024 as expeditiously as possible.
