4.The learned Additional Government Pleader who takes notice for the respondents would submit that the application submitted by the petitioner will be considered in accordance with law.

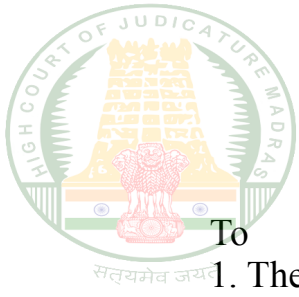
