ORDER

The petitioner has submitted a representation seeking permission to conduct Adal Padal Program on 13.07.2025 from 6.00 p.m. to 10.00 p.m. in connection with the temple festival of Arulmigu Shri Shyamala Devi Kalamman Thirukovil, Arasamaratheru, Nadukaveri, Thiruvaiyaru Taluk, Thanjavur District. The first respondent, by his proceedings dated 08.07.2025, rejected the petitioner's representation. Challenging the same, the petitioner has filed this writ petition.

2. The learned Additional Public Prosecutor submits that within two months, five incidents had taken place in the village and a murder had also been taken place. In view of the recent incidents taken place in the village, they are apprehending that there may be a law and order problem in the village.
