6.With the above directions, the Writ Petition stands disposed of. No costs.

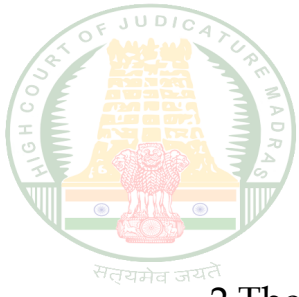
