Since the petitioner was facing charges under Rule 17(b) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules, at the relevant point of time, this Court is not inclined to grant any relief as prayed for in this writ petition. However, it is open to the petitioner to workout his remedy based on the outcome of the disciplinary proceedings.

4. Accordingly, this writ petition is closed. No costs. Consequently, connected miscellaneous petitions are closed.
