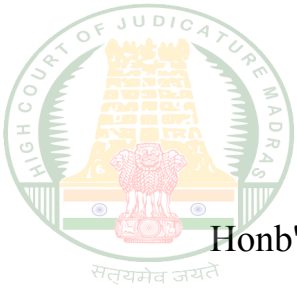

ORDER

This writ petition has been filed for a writ of Mandamus to direct the respondents 1 to 4 to consider and dispose of the petitioner's representation dated 28.01.2025, seeking to take action against the fifth respondent.

2. It is well settled that a third party, not connected with any service dispute, can invoke the provisions of Article 226 of the Constitution of India to seek a mandamus to take action against any employee or official. Disciplinary proceedings is essential matter between employer and the employee and a stranger particularly, a person who was the complainant which led to a criminal case, cannot claim to initiate departmental action. The said principal has been laid down by the
