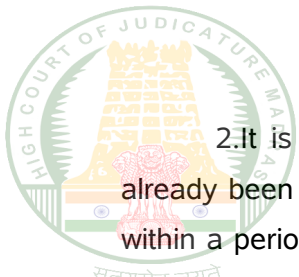

Both the parties and their respective counsels are present and they arrived at an amicable settlement for a sum of Rs.6,00,000/- [Rupees Six Lakhs Only] as full quit.

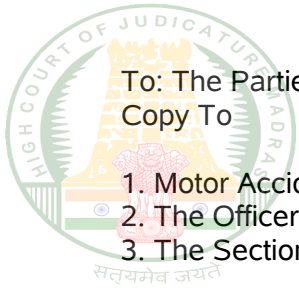
The Original of the award shall be place in the court record and copy of the award, kept with High Court Legal Services Committee and one copy each is furnished to both parties free of cost.
