ORDER : The Court made the following order :-

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.7365 of 2025 dated 23.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.7365 of 2025 dated 23.04.2025 and enlarged the petitioner herein on anticipatory bail. He further submits that the petitioner is working in Army, due to the same, he is not able to arrange the sureties and surrender before the concerned Court.
