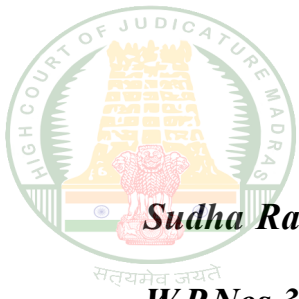

ORDER

The present Writ Petition has been filed for the issuance of a *Writ of Mandamus*, directing the 5th respondent to issue no objection certificate to the petitioner and subsequently direct the 2nd respondent to register the petitioner's power of attorney dated 14.03.2025 forthwith.

2. It is seen from the records that the 2nd respondent has refused to register the petitioner's power of attorney dated 14.03.2025 since the land belongs to the temple. This issue was already considered by this Court in the case of

issue notice to the petitioner and the temple and conduct enquiry and pass orders.

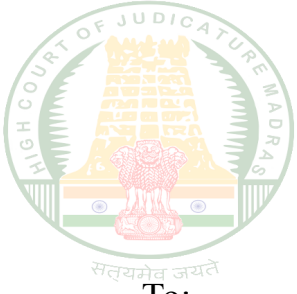
3. Therefore, the 2nd respondent is directed to conduct an enquiry and pass orders in accordance to law.
