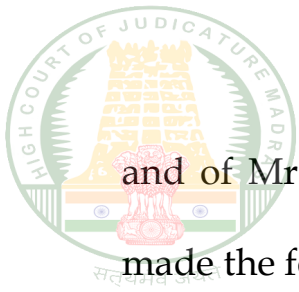
Prayer in W.A.(MD). No. 673 of 2023:
