3. The learned Government Advocate (Criminal Side) appearing for the respondent police would submit that the petitioners have complied with the condition regularly.

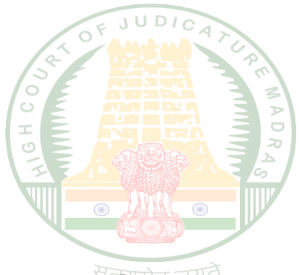
