The learned counsel appearing for the petitioner seeks permission of this Court to withdraw these petitions and he has also made an endorsement to that effect.

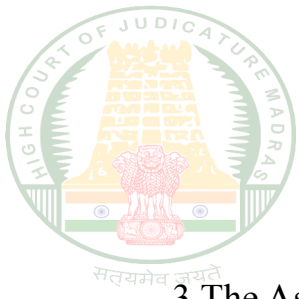
