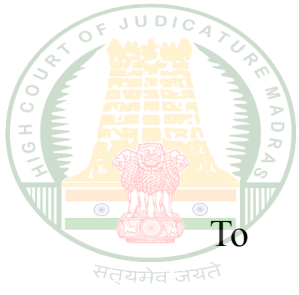
WEB COPY 2.Establishing direct purchase centres is the administrative decision of the Department. Court cannot interfere with such administrative decisions.

3.The writ petition has been instituted to seeking negative relief which cannot be considered. Place, where the centre is to be established and the procedure to be followed are the administrative prerogative of the Government Department, which would not fall under the realm of the power of judicial review.

4.Thus, the writ petition stands dismissed. There shall be no order as to costs. Consequently, the connected miscellaneous petition is closed.
