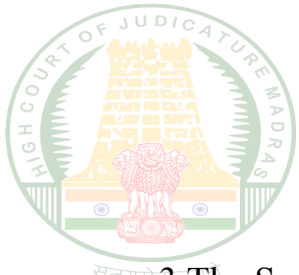
2. Recording the same, the habeas corpus petition is closed.
