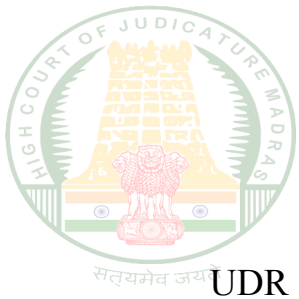

ORDER

The petitioner herein seeks a direction to the respondents to consider her representation dated 24.03.2025 and expedite the enquiry in the proceedings pending on the file of the second respondent in O.Mu.No.3197293/2025/G5.

2. Heard the arguments of Mr.R.Manoharan, learned counsel appearing for the petitioner and Mr.A.Baskaran, learned Additional Government Pleader, who takes notice for the respondents. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.
