ORDER

2. The learned Additional Government Pleader appearing for the respondents 1 to 4, on instructions, submitted that the District Collector / first respondent has requested the Revenue Divisional Officer / second respondent to submit a report. Only after receiving the report, the District Collector can pass appropriate orders.

3. In view of the above, this Court is directing the Revenue Divisional Officer / second respondent to submit a report within a period of six (6) weeks from the date of receipt of a copy of this order. Thereafter, the District Collector /

first respondent shall conduct an enquiry, after issuing notice to all interested parties, and pass appropriate orders within a period of four (4) weeks therefrom.

4. With the above observations, this Writ Petition is disposed of. There shall be no order as to costs.
