This criminal miscellaneous petition has been filed seeking to suspend the sentence imposed on the petitioners by the II Additional District and Sessions Court, Tiruchirappalli, in S.C.No.220 of 2021, dated 26/06/2025 and to enlarge the petitioners on bail pending disposal of the criminal appeal.

2.The petitioners stand convicted and sentenced as under:-

Section of Law	Sentence of imprisonment	Fine amount
342 IPC	One month SI	Nil
302 IPC	Life Imprisonment	Rs.1,000/-, in default to undergo a simple imprisonment

3.Heard the learned counsel on either side and perused the materials available on record.

4.The petitioners have made out a *prima facie* case to grant suspension of sentence, hence we are of the opinion that it is a fit case for grant of suspension of sentence to the petitioners.

5. Accordingly, the Criminal Miscellaneous Petition is **allowed** and the substantive sentence of imprisonment alone imposed on the petitioners is suspended subject to the following conditions:-

(i). The petitioners are directed to be enlarged on bail, each on executing a bond for Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the **II Additional District and Sessions Court, Trichy.**

(ii). The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Trial Court may obtain a copy of their Aadhar card or Bank passbook to ensure their identity.

(iii). The petitioners shall appear and sign before the trial Court at 10.30 am, on the first working day of every English Calendar month till the disposal of the Criminal Appeal.
