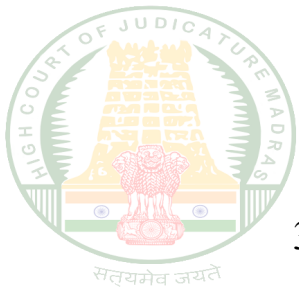

ORDER

This criminal original petition has been filed to quash the charge sheet in C.C.No.64/2024 pending on the file of the Learned Judicial Magistrate Court, Pattukottai, Tanjore.

2.The learned counsel appearing for the petitioners submits that the allegations levelled in FIR are baseless and the first respondent has also conducted the investigation and filed the final report mechanically. Accordingly, he prays to quash the impugned proceedings.
