2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.8681 of 2025 dated 13.06.2025 and enlarged the petitioner on anticipatory bail. He further submits that after receiving the order copy, it was found that the crime number in the above said anticipatory order was wrongly mentioned as Crime No.142/2025 instead of Crime No.141/2025.
