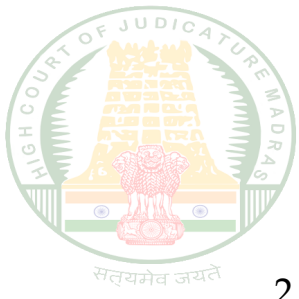

5.Accordingly, this criminal miscellaneous petition is ordered.

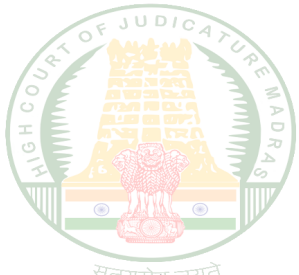
