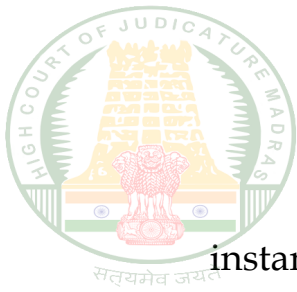

ORDER

The Petitioner herein seeks a direction to the respondents to conduct survey of the property in S.No.108/2 measuring an extent of 5 cents situated at Naripaiyur Group Village, Kadaladi Taluk, Ramanathapuram District by considering the Petitioner's representation, dated 8.7.2025.

2.Mr.A.Baskaran, learned Additional Government Pleader takes notice for the respondents 1 and 2. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.According to the Petitioner, the subject property was purchased by his father Veerapathiran under registered sale deed, dated 29.6.1978 and joint patta for the subject property stands in the name of the Petitioner and six others in Patta No.590.The Petitioner submitted an online application on 30.6.2025 in Application No.2025/0123/27/006527 seeking survey of the property. The same has not been considered so far. Hence the

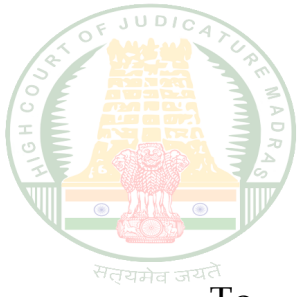
