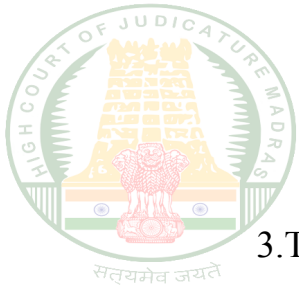

JUDGMENT
