PRAYER :- Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to take appropriate action on the petitioner's complaint / representation dated 28.06.2024 and to provide necessary police protection for quarry operation in the land ad-measuring to an extent of 1.94.50 Hectares of patta land in Survey No.807 of Naranammalpuram Part-I Village, Tirunelveli Taluk, Tirunelveli District in terms of Quarry Lease granted by the Joint Director / Assistant Director of Geology and Mining, Tirunelveli District vide his proceedings in RC. 2. According to the petitioner, he is not operating the quarry at present and whenever he attempts to open the quarry, the private respondents are preventing the operation.

3. The learned Additional Public Prosecutor would submit that the earlier complaint / representation given by the petitioner was considered and the same was closed, as there is no interference from any person in running of the quarry.

4. Recording the abovesaid submission, this Writ Petition is dismissed, with liberty to the petitioner to approach the respondents 1 to 4, if there is any threat or interference in future. Consequently, connected Miscellaneous Petition is closed.
