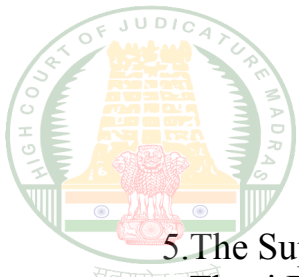

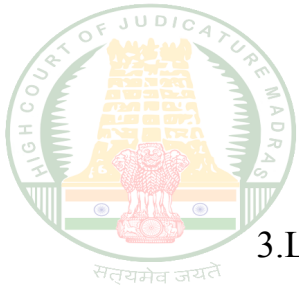

JUDGMENT
