4.The learned counsel for the petitioner submits the petitioner would appear on 26.07.2025 for enquiry before All Women Police Station and co-operate for enquiry.

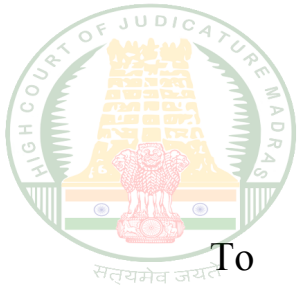
