3.The learned Special Public Prosecutor of NCB Cases would submit that the petitioner is complying with the conditions imposed by this Court regularly.

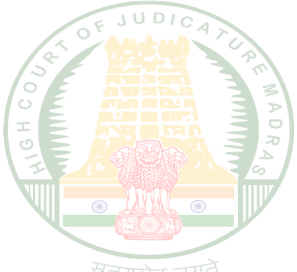
