The petitioner herein seeks a direction to fourth respondent to consider his application for issuance of subdivision patta in application No. 2025/0105/24/718766, dated 05.04.2025.

2. According to the petitioner, he purchased 5123 sq.ft. of land in Survey No.12/4B2 and 11460 sq.ft. in Survey No.12/4B2 and 12/5b in Vandipur First Bit Village, Madurai North Taluk. He submitted an application on 05.04.2025 in application number 2025/0105/24/718766, seeking subdivision patta. The same has not been considered. Hence, the petitioner has come before this Court.

3. The learned Government Advocate, who takes notice for the respondents, would submit that third parties have submitted some objections and, therefore, the application of the petitioner would be considered, after issuing notice to the objectors.
