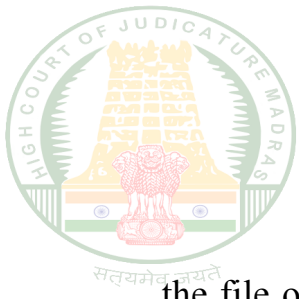

ORDER

This petition has been filed by the petitioners to call for the records pertaining to the C.C.No.293 of 2023 on the file of the learned Additional Mahila Court, Madurai and quash the same.

2. According to the petitioners, the defacto complainant is known person to the petitioners. Based on the complaint given by the second respondent/defacto complainant, the police has registered an FIR in Crime No.5 of 2022. After investigation filed Final Report and the Trial Court has taken cognizance for the offences under Sections 498(A) and 506(1) of the Indian Penal Code, 1860.

6. Considering the nature of the offences, the relationship between the parties and they have also entered into a compromise, it is appropriate to allow this petition.

7. Recording the said compromise, this petition is allowed and C.C.No. 293 of 2023 on the file of the learned Additional Mahila Court, Madurai is
