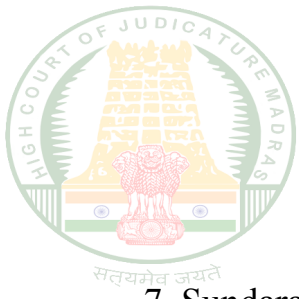

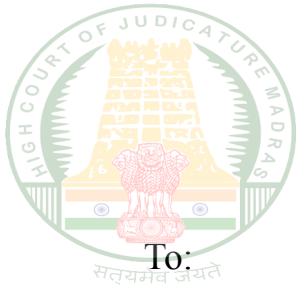
2. The learned Special Government Pleader, on instructions, submitted that the permission sought by the private respondents has already been rejected through the impugned order dated 18.07.2025.
