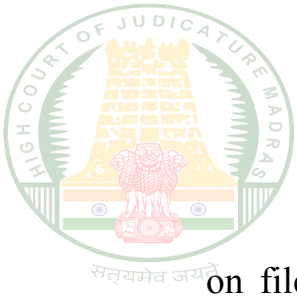

ORDER

The petitioners are accused Nos.1 and 2 in Crime No.191 of 2025 registered on the file of the 1st respondent for the offence under Section 303(2) of BNS. They have moved this petition to quash the proceedings in FIR in Crime No.191 of 2025 registered against them.

2. When this petition is taken up for hearing, the learned Government Advocate (Crl. Side) submits that investigation was completed and the final report has also been filed before the Judicial Magistrate, Devakottai, through e-filing in LTN20220002436C202500250, on 04.07.2025.

3. Since it is reported that the final report has been filed in Crime No. 191 of 2025, without ascertaining the materials relied on by the investigating agency in the final report, this Court is not inclined to proceed with the available FIR. Therefore, this Criminal Original Petition is dismissed with liberty to the petitioners to challenge the final report, if they are having any ground. Mere filing of the final report through e-filing is not sufficient. The respondent Police shall ensure that the final report is taken
