ORDER: The Court made the following order :-

The petitioner/ Accused Rank Not known, who apprehend arrest at the hands of the respondent police for the offences punishable under sections 296(b), 118(1) of BNS in Crime No. Not known of 2025 on the file of the respondent police, seeks anticipatory bail.

2. Today, when the matter is taken up for hearing, the learned Government Advocate (Criminal Side), on instructions from the respondent Police, submitted that the enquiry is pending in CSR.No. 1079 of 2025 against the petitioner.

3. The learned Counsel for the petitioner submitted that the respondent police is harassing the petitioner under the guise of enquiry.

4. Considering the facts and circumstances of the case, the respondent police is directed to follow the procedure under Section 35 of BNSS, and to conduct the enquiry and if any prima facie case is made out against the petitioner, register the F.I.R. or close the petition enquiry within a period of two weeks from the date of receipt of a copy of this order.
