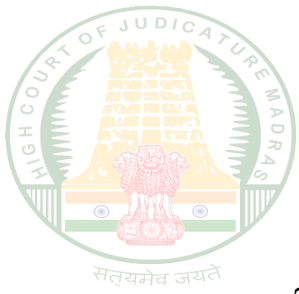
Prayer in WP(MD)NO.22573 of 2019:-

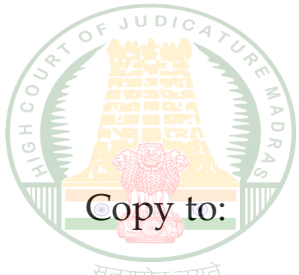
