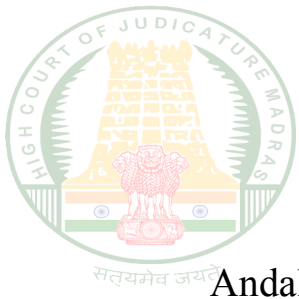

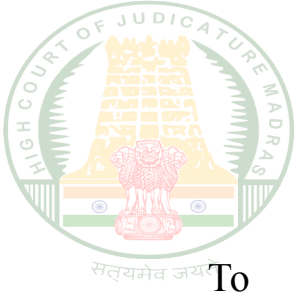

Andal Temple in this month and the major police force have to be deployed to the temple, in order to maintain order, managing traffic, and preventing any potential disruptions and therefore, they are not in a position to provide police protection as required by the petitioner to conduct the protest. However, they are prepared to provide police protection, if the petitioner changes the date of protest to the first week of August 2025.

3. Recording the submissions of the learned Additional Public Prosecutor, this writ petition is closed with liberty to this petitioner to file a fresh application changing the date of protest and the same shall be considered by the respondent police, imposing necessary restrictions/conditions. No costs.
