The learned counsel appearing for the petitioner would submit that the first respondent filed a suit for restraining the petitioner herein from interfering with the construction constructing the ablution fountain in the schedule property and permanent injunction restraining the petitioner from interfering with day to day affairs and administration of the Hazrath Thable Alam Badhusha, Nathar Vali Dargha Wakf and its Mosque and burial ground G.S.No.739/Trichy.
