**ORDER :** The Court made the following order :-

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.6069 of 2025 dated 02.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an anticipatory bail order in Crl.O.P.(MD).No.6069 of 2025 dated 02.04.2025 and enlarged the petitioner on anticipatory bail by imposing certain conditions. He further submits that due to ill health and financial condition, this petitioner is unable to arrange the amount to comply the deposit condition and he is also unable to arrange the sureties and produce before the concerned Court within the time stipulated by this Hon'ble Court.
