This petition has been filed for extension of time for compliance of the conditional order passed in CrI.O.P(MD).No.7212 of 2025 dated 29.04.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an anticipatory bail order in CrI.O.P.(MD).No.7212 of 2025 dated 29.04.2025 and enlarged the petitioner on anticipatory bail by imposing certain conditions. He further submits that this petitioner is working as daily wager in other District, he is unable to arrange the sureties and produce before the concerned Court within the time stipulated by this Hon'ble Court. For the said reason only, he is unable to comply the conditions imposed by this Court in CrI.O.P.(MD).No.7212 of 2025 dated 29.04.2025. Hence, he prayed to extend the time period, by allowing this Criminal Miscellaneous Petition.

4. Considering the submissions made by the learned Counsel for the Petitioner and being satisfied with the reasons stated above, this Court is inclined to extend
