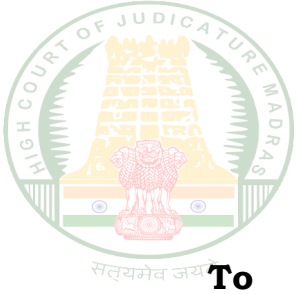
The learned counsel for the petitioner submitted that
