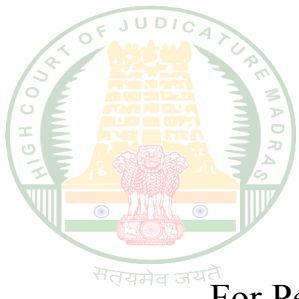

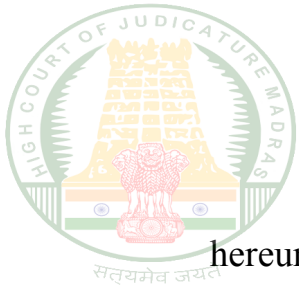

Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a writ of certiorari calling for the records pertaining to the impugned order passed by the first respondent in his proceedings in Na.Ka.No.34561/2017/C4 dated 04.04.2018 and consequential impugned order passed by the third respondent in Na.Ka.No.3909/2018/A dated 13.04.2018 and quash the same as illegal.

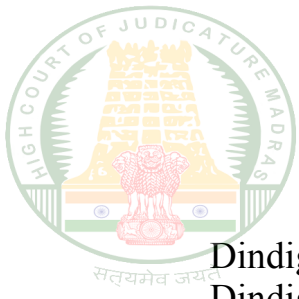
