WEB COPY ORDER: The Court made the following order :-

The petitioners/ Accused Rank Not known, who apprehend arrest at the hands of the respondent police for the offences punishable under sections 137(1)(b), 142 of BNS in Crime No. Not known of 2025 on the file of the respondent police, seeks anticipatory bail.

2. Today, when the matter is taken up for hearing, the learned Government Advocate (Criminal Side), on instructions from the respondent Police, submitted that the enquiry is pending in CSR.No.189 of 2025 against the petitioners.

3. The learned Counsel for the petitioners submitted that the respondent police is harassing the petitioners under the guise of enquiry.

4. Considering the facts and circumstances of the case, the respondent police is directed to follow the procedure under Section 35 of BNSS, and to conduct the enquiry and if any prima facie case is made out against the petitioners, register the F.I.R. or close the petition enquiry within a period of two weeks from the date of receipt of a copy of this order.
