Heard the arguments of M/s.M.Viji, learned counsel appearing for the petitioner, Mr.D.S.Nedunchezian, learned Government Advocate appearing for the respondents 1 to 3 and Mr.M.Vaikkam Karunanithi, learned Government Advocate (crl.side) appearing for the fourth respondent. Since no adverse order is passed against the respondents 5 and 6, notice to them is dispensed with.

3. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

4. According to the petitioner, the subject properties were purchased by him under registered sale deeds dated 23.08.2023 and 29.01.2025. The pattas for the subject properties were issued in the name of the petitioner in Patta Nos.1308 and 1475. The petitioner submitted an online application on 17.06.2025 in Application No. 2025/0123/13/013096 seeking survey of the subject properties and the same has not been considered. Hence, the petitioner has come before this Court.
