ORDER

The Petitioner herein seeks a direction to the respondents to survey the property in S.NO.107/27 situated at Puthunilaivayal, Arimalam Panchayat, Thirumayam Taluk, Pudukkottai District within the time stipulated by this Court.

2.Mrs.K.Malathi, learned Additional Government Pleader takes notice for the respondents 1 and 2. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.According to the Petitioner, the subject property was purchased under registered sale deed, dated 13.2.2025 and patta for the subject property stands in the name of the Petitioner in Patta No.7927. The Petitioner submitted an online application on 22.04.2025 in Application No.2025/0123/22/008921 seeking survey of the property. The same has not been considered so far. Hence the instant Writ Petition has been filed by the Petitioner for the aforesaid relief.

4.Mrs.K.Malathi learned Additional Government Pleader who takes notice for the respondents 1 and 2 would submit that

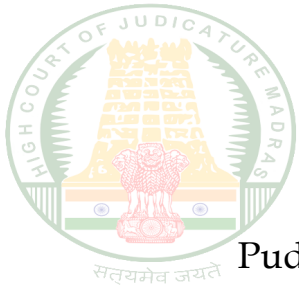
